*2022 Special Assessment: The BCCC Board of Directors is assessing \$20 per membership to cover the Board liability insurance, attorney fees, supplies for the board election and miscellaneous expenses.

Otherwise, range balls will be priced at \$7 for a small bucket and \$11 for a large bucket.
